**Professor/university professor positions  
academic positions in the group of researchers and lecturers are available  
at the Faculty of Mathematics, Informatics and Mechanics**

Pursuant to the Law of Higher Education, the University of Warsaw invites the applications for a position of Professor/University Professor in the group of researchers and lectures in the **Institute of Applied Mathematics and Mechanics**, with specialization in **Statistics (Mathematics)**.

**Terms of employment:** starting date October 1st, 2021, full time job, competitive salary, fixed term employment contract for 4 years. On positive assessment in the first year of the employment, the contract can be extended for an indefinite period. The candidates should be committed to research in Mathematics or Computer Science, respectively, and teaching (teaching hours per academic year: 210, or 180 in the case of candidates having a professor's title).

**Requirements. Successful candidates for the Professor/university professor position should have:**

1. at least a doctoral degree, in Mathematics, Computer Science or a related field;
2. a significant academic record in Statistics, demonstrating academic autonomy;
3. international experience;
4. experience in undertaking and managing research projects;
5. significant teaching achievements;
6. experience of participation in the education of young academics;
7. organisational achievements;
8. a positive opinion from the University Senate.

**Applications should be submitted to the Dean's office via e-mail with the following attachments:**

1. a cover letter addressed to the Dean of the Faculty of Mathematics, Informatics and Mechanics,
  - with the signed consent to the processing of personal data for the purpose of recruitment in accordance with the GDPR Regulations (cf. attachment);
  - containing the phrase: *I hereby confirm that I am aware that the recruitment process is an open competition, governed by the [Statute of the University of Warsaw](#), par. 115, 117 and I accept these rules.*
2. a copy of a PhD diploma;
3. an academic CV with a list of publications, cf. sample documents at [http://www.mimuw.edu.pl/dla\\_pracownika/dok-form/dokumenty/konkurs/](http://www.mimuw.edu.pl/dla_pracownika/dok-form/dokumenty/konkurs/);
4. copies of selected publications (not more than 3);
5. a description of the research projects to be conducted by the candidate (not more than 2 pages);
6. names, affiliations and contact details of 3 possible referees.

All documents should be sent as **PDF files** to the email address: [konkursy@mimuw.edu.pl](mailto:konkursy@mimuw.edu.pl). The files should be marked with the name, last name and position of a candidate.

**Application deadline: February 12th, 2021**

The applications will be evaluated by the selection committee appointed by the Dean of the Faculty of Mathematics, Informatics and Mechanics, University of Warsaw, Poland. A candidate may be invited to an interview by the committee. The decision date is May 31st, 2020 (an e-mail notification will be provided). The competition is the first stage of the recruitment process as described in the [Statutes of the University of Warsaw](#) the recommendation by the selection committee being a basis for subsequent stages.

## Information on personal data processing

### Controller

Controller of your personal data processed in connection with the recruitment process is the University of Warsaw, ul. Krakowskie Przedmieście 26/28, 00-927 Warszawa, as the Employer. Contact with the controller:

### Data Protection Officer (DPO)

Controller has designated Data Protection Officer whom you may contact via email at [iod@adm.uw.edu.pl](mailto:iod@adm.uw.edu.pl). You may contact the DPO in all matters relating to your personal data processing by the University of Warsaw and the exercise of rights in relation to the processing of personal data.

The DPO, however, does not proceed other matters, like handling recruitment procedures, collecting recruitment documents, providing information on current recruitment process.

### Purpose and legal grounds of data processing

Personal data of candidates for employment shall be processed for recruitment purposes only.

Your personal data shall be processed in the scope as indicated by employment law<sup>1</sup> (*given name (names) and family name, date of birth, contact information as provided, education, professional qualifications, previous employment*) for the purposes of this recruitment process<sup>2</sup>, whereas other data<sup>3</sup> shall be processed based on your consent which may take the following wording:

*I agree to the processing of personal data provided in .... (e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.*

If your documents include data as mentioned in Art. 9 section 1 of the GDPR (special categories of personal data), processing shall be possible upon your consent to processing such data<sup>4</sup> which may take the following wording:

*I agree to the processing of special categories of personal data, as mentioned in Art. 9 section 1 of the GDPR, provided in ..... (e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.*

The University of Warsaw shall be also processing your personal data in future recruitment processes upon your consent<sup>5</sup> which may take the following wording:

*I consent to processing of my personal data for the purposes of any future recruitment processes at the University of Warsaw for the period of the next nine months.*

You may revoke all such consents at any time by, for example, sending an email at ..... (email address due for the recruitment process).

Be advised that the revocation of your consent does not affect legal compliance of processing which had been completed upon consent before its revocation.<sup>6</sup>

**Data retention period**

Your personal data collected in this recruitment process shall be stored over the period of three months from the date the recruitment process is completed.

In case you agree to process your data in future recruitments, your data shall be used over the period of nine months.

**Data recipients**

Officers authorized by the Controller shall have access to your personal data, the processing of which is in the scope of their duties.

Recipients of personal data may be other subjects obligated by the Controller to provide specific services involving data processing, like

**Data transfer outside the European Economic Area (EEA)**

Your personal data shall be disclosed to subjects authorized by law. Signing-in is through Google Forms. Your personal data may be also processed by our provider of G-Suit for education by Google Company in their data processing centres.<sup>7</sup> Your data shall be protected under the standards of the Privacy Shield, accepted by the European Commission.<sup>8</sup> This shall guarantee an adequate level of data security.

**Rights of the data subject**

Under the GDPR data subjects have the following rights:

- to access data and to receive copies of the actual data;
- to correct (rectify) your personal data;
- to restrict processing of personal data;
- to erase personal data, subject to provisions of Art. 17 section 3 of the GDPR;
- to file a claim with the President of the Personal Data Protection Office, if you believe data processing violates law.

**Information on the requirement to provide data**

Providing your personal data in the scope resulting from law is necessary to participate in the recruitment process. Providing other personal data is voluntary.
